

REQUEST FOR MAIL BALLOT OR REPLACEMENT BALLOT

TO THE DESIGNATED ELECTION OFFICIAL OF THE ALPENSEE WATER DISTRICT

I do solemnly swear or affirm that I am a citizen of the United States of the age of eighteen years or older; that I am registered to vote in general elections in the State of Colorado, pursuant to the "Uniform Election Code of 1992," as amended; and that I have not previously voted at this election.

I am further qualified to vote in this special district election as:

IF AN ELECTOR REQUESTS A REPLACEMENT BALLOT AND RETURNS THE ORIGINAL AND THE REPLACEMENT BALLOTS, THE FIRST BALLOT RECEIVED BY THE DESIGNATED ELECTION OFFICIAL SHALL BE CONSIDERED THE OFFICIAL BALLOT.

Colorado law requires that in order for your ballot to be counted it must be received by 7:00 p.m. on the day of the election.
